**SECTION 4. First aid measures****4.1. Description of first aid measures****Inhalation:**Air the area. Move immediately the contaminated patient from the area and keep him at rest in a well ventilated room.

If breathing has stopped, give artificial respiration.

Direct contact with skin (of the pure product).:

Take contaminated clothing Immediately off.
